Landing Pages Send PPC Leads to Your Email

A landing page is a web page designed to turn pay-per-click (PPC) traffic into measurable leads. After users click on one of your PPC ads, they will immediately "land" onto a special kind of page where they are enticed to fill out an online lead form, which is then sent to your email.

Web and Graphic Design

Directory One will design an attractive web page, remove unnecessary links, and place your form prominently on the page, all to maximize the chances of generating a lead.

Web Page Content Development

Content for your PPC landing pages will be written to effectively describe your offer and entice visitors to fill out your form.

Custom Form Programming

Your online form will be custom programmed to gather the information you need. As few or as many fields as you like can be added to gather names, addresses, phone numbers, etc. The form will also send leads to the email(s) of your choice.

Landing Page Tracking

A special code will allow you to track when someone fills out your lead form. You'll be able to tell which PPC ad the lead entered through and which keywords prompted that ad to appear. This way you can tell which ads and keywords are most profitable.
